



**Coronavirus/COVID-19
Assumption of Risk and Waiver of Liability**

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments, and federal and state health agencies, recommend social distancing and have, in many locations, prohibited the congregation of groups of people. By signing this Waiver of Liability, you represent to Fin & Fowl Outfitters LLC and its parent, subsidiary, and affiliated entities, and all entities conducting operations with Fin & Fowl Outfitters LLC (together and collectively, "Fin & Fowl") and that you and your guest have not, in the past 14 days: knowingly been in contact with anyone that has tested positive for COVID-19; exhibited any symptoms commonly associated with COVID-19, including fever; or traveled outside the United States. To address the risks that COVID-19 presents, including to reduce the spread of COVID-19, Fin & Fowl has adopted preventative measures and protocols. However, if you or your guest attend a Fin & Fowl event, Fin & Fowl does not and cannot guarantee that you or your guest will not be exposed to or become infected with COVID-19, or spread of COVID-19 to others.

By signing this Assumption of Risk and Waiver of Liability, you expressly and knowingly:

1. Acknowledge the contagious nature of COVID-19.
2. Voluntarily assume the risk that you or your guest may be exposed to or infected by COVID-19 at a Fin & Fowl event. You voluntarily agree to assume the risk that you or your guest may be exposed to or infected by COVID-19 at a Fin & Fowl event, and that if infected, you or your guest could spread COVID-19 to others.
3. You accept sole responsibility for any mental distress, personal injury, illness, temporary or permanent disability, and/or death that you, your guest or others with which you have personal contact may experience or incur if you become COVID-19 infected as a result of you or your guest attendance at a Fin & Fowl event.
4. You waive and release Fin & Fowl and all associated officers, directors, members, directors, managers, agents, employees, representatives, volunteers, and/or all other Fin & Fowl event participants and/or their families ("Fin & Fowl Parties") from all actions, damages, losses, costs, claims, liability, or expense, of any kind or nature, that you or your guest suffer or incur from exposure to or infection by COVID-19 as a result of attending, arising out of, or related to, a Fin & Fowl event (a "Claim").

On your behalf, and on behalf of your guest, you hereby release, covenant not to sue, discharge, and hold harmless Fin & Fowl and the Fin & Fowl Parties from and against the Claims. You understand and agree that this release includes any Claims based on the actions, omissions, or negligence of Fin & Fowl or a Fin & Fowl Party, including any Claim based on lack of, or error in carrying out, COVID-19 preventative measures and protocols, and regardless of whether a COVID-19 exposure or infection occurs before, during, or after participation in any Fin & Fowl event.
