



**RELEASE OF LIABILITY AND ACKNOWLEDGMENT
AND ACCEPTANCE OF DANGERS, RISKS AND
HAZARDS OF PREMISES**

In consideration of being granted access to the property owned, leased or otherwise controlled by FIN & FOWL OUTFITTERS LLC (the "Premises"), and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the undersigned, on the one hand, and FIN & FOWL OUTFITTERS LLC, Brian Davenport, Rian Glasscock and Tony Cirillo, on the other hand (collectively, "FIN & FOWL"), hereby acknowledge and agree as set forth below:

1. My presence and activities on the Premises expose both me, my dog and my property to dangerous conditions, risks, and hazards, including but not limited to: poisonous snakes, insects and spiders, blinds and tree stands (whether or not erected by FIN & FOWL), erosion and general condition of the land (both on and off the roadways) creating rough, hazardous and dangerous driving and walking conditions, animals (both wild and domestic) that may be diseased and/or potentially dangerous, deep water, persons with firearms and the use of vehicles (collectively, the "Dangerous Conditions").
2. I hereby expressly assume all dangers, risk and hazards relating to or arising out of the Dangerous Conditions and hereby irrevocably release, acquit and forever discharge FIN & FOWL and each of their respective agents, employees and assigns from and against any and all claims, demands, causes of action and damages, including attorney's fees, whether now existing or which may hereinafter come into existence, whether now or hereinafter fully, partially or undiscovered, which I had, now have or may ever have, resulting from any accident, incident or occurrence arising out of, incidental to, or in any way resulting from the Dangerous Conditions and the use of the Premises and any improvements thereon.
3. I will protect, indemnify and hold harmless FIN & FOWL, and each of their respective agents, employees and assigns from and against any and all claims, demands, causes of action and damages, including attorney's fees, whether now existing or which may hereinafter come into existence, whether now or hereinafter fully, partially or undiscovered, resulting from any accident, incident or occurrence arising out of, incidental to, or in any way resulting from the Dangerous Conditions and the use of the Premises and all improvements thereon, whether or not caused by FIN & FOWL's negligence, gross negligence or willful misconduct.
4. I, my heirs, successors and assigns will not make any claim, or institute any suit or action at law or in equity against FIN & FOWL and each of their respective heirs, agents, representatives, employees, successors or assigns. As used in this release, the terms "I", "my person" and "myself" include minors in my care while on the Premises.
5. The acknowledgements and agreements contained herein shall apply during all times that I am permitted on the Premises.
